- **Faculty Affairs Committee Comment:** What does "good academic and citizenship standing" mean, specifically the use of citizenship in this instance (procedure summary)?
- Section 1.3 Faculty Affairs Committee Comment: What is the definition of an institution-sponsored activity? Is this defined in another procedure? If not, could this be defined here.
- **Section 2** Moved 2.2 to 2.5 to better reflect the process flow.

- Faculty Affairs Committee Comment: This is misleading, and not accurate. Outside of the library, I doubt very many departments contribute to librarianship, nor would/should they be expected to do so. We suggest striking this or drastically rewriting this section.
- Section 2 Faculty Affairs Committee Comment: How exactly are faculty expected to be involved in career counseling? Should this maybe say mentorship instead?
