- January 1: Changes to be implemented July 1 December 31 of the same year
- July 1: Changes to be implemented January 1 June 30 of the following year

New Program: The percentage of new curriculum that will make up the new program determines whether the institution needs to notify SACSCOC or seek approval. Existing curriculum that is repackaged into new courses do not count towards this percentage.

SACSCOC Substantive Change Quick Reference Guide

Program Length Change: Increasing or decreasing the length of a program **requires SACSCOC approval if:**

- the credit hours (or equivalent measure) increase or decrease by 25% or more and
- the expected time for students to complete the program increases or decreases by more than one term.

Cooperative Academic Arrangements

- with Title IV Entity(ies): Delivering a program through a cooperative academic arrangement with a Title IV entity (or entities) requires notification to SACSCOC if:
 - o 50% or more of the program is offered through the arrangement or
 - o the institution could not deliver the program without the arrangement
- with non-Title IV Entity(ies)
